GUESTS AND BEDNIGHTS BY PLACE OF RESIDENCE



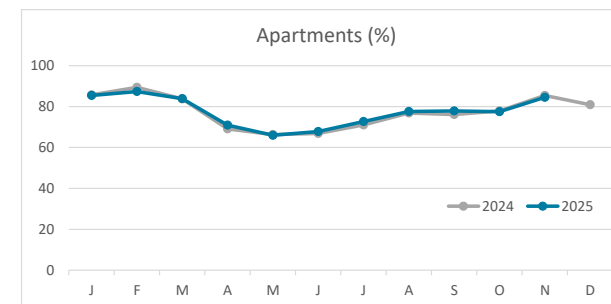
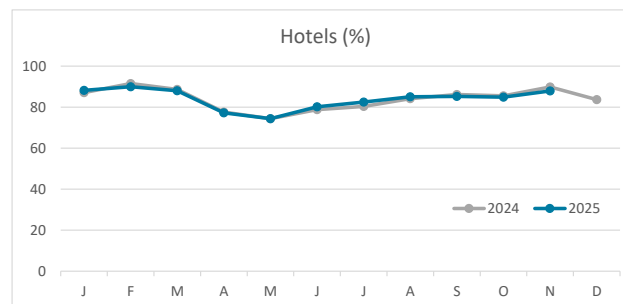
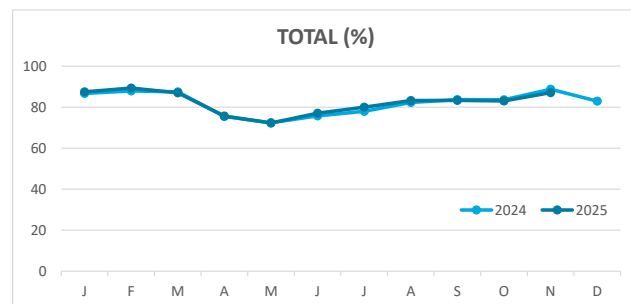

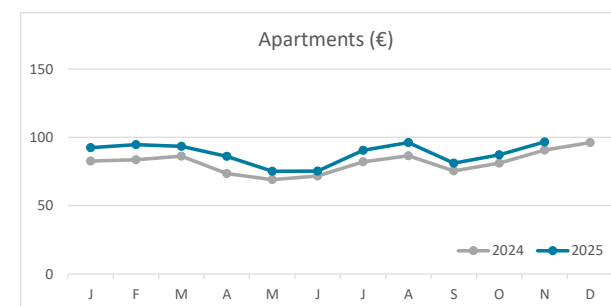

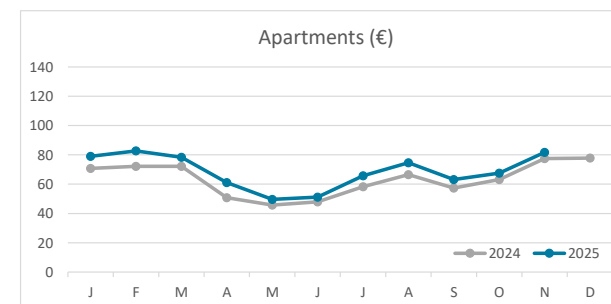
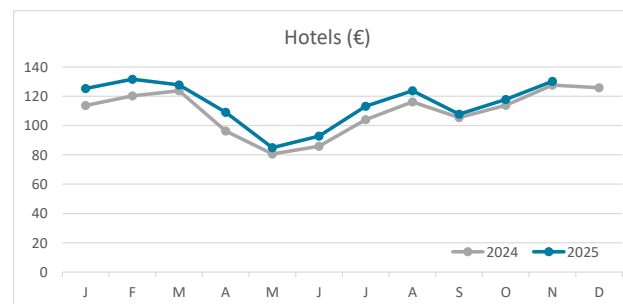
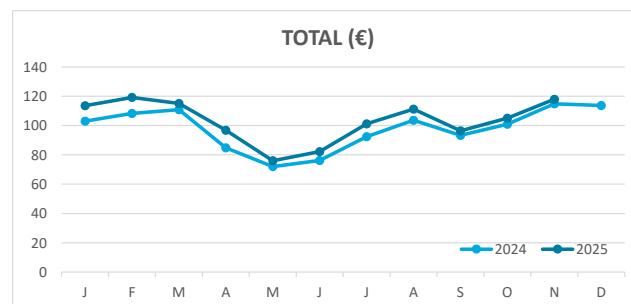
OCCUPANCY RATE PER ROOM / APARTMENT

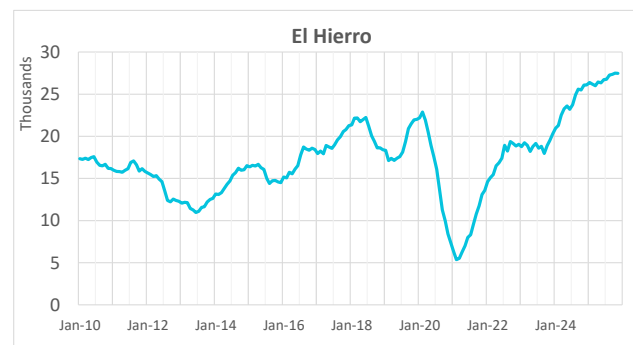

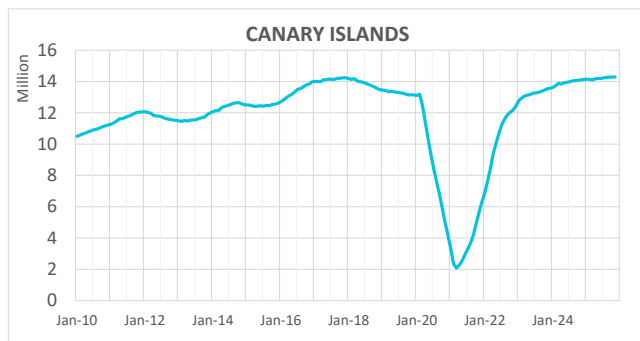
